Re. 1.

Mirosław Bendzera is responsible for the FAMUR Group's strategy and development.

He graduated from the Kraków University of Economics and holds a master's degree in management and marketing. He has extensive experience serving on management and supervisory bodies of companies operating in the industrial sector. He served in the governing bodies of Ponar Wadowice S.A. and Ponar Silesia S.A. and held a managerial position at Toyota Motor Poland Co. Ltd. Since 2009, he has sat on management boards of companies affiliated with the TDJ Group. He was President of the Management Boards of Odlewnia Żeliwa Śrem S.A. and Pioma-Odlewnia Sp. z o.o. (2009–2014) and of Polska Grupa Odlewnicza S.A. (2011–2014). From 2013 to 2018, he was a member of the Board of TDJ's Foundation for the Promotion of Education and Development (Fundacja TDJ Na Rzecz Edukacji i Rozwoju). In October 2014, he became President of the FAMUR S.A. Management Board. From January to July 2016, he was also a member of the Management Board of Elgór+Zamet Sp. z o.o. She has secondary education as an alumna of the Karol Miarka General Secondary School in Mikołów. Her responsibilities include coordination of finance and accounting activities of the FAMUR Group. She has extensive experience serving on management and supervisory bodies of companies operating in the industrial sector. Since 1998, she has served on the management boards of companies affiliated with the TDJ Group, i.e. the main shareholder of FAMUR S.A. She has sat on the Management Board of FAMUR S.A. since the Group's inception in 2002. She is responsible for coordination of finance and accounting activities of the FAMUR Group and raising financing. She was also responsible for bringing new Group companies into compliance with International Accounting Standards. She is also Vice President of the Management Board of TDJ S.A. In 2016, she was appointed President of the Management Board of PRIMETECH S.A. (formerly KOPEX S.A.). She is a member of the supervisory boards of companies related to the TDJ Group and the FAMUR Group, including FAMUR FAMAK S.A., MINING EQUIPMENT FINANCE SP. Z O.O., PME S.A., Śląskie Towarzystwo Wiertnicze DALBIS Sp. z o.o.

Adam Toborek is in charge of the FAMUR Group's Underground segment export sales.

He holds a university degree. He completed the Master of Business Administration programme at the Kozminski University in Warsaw. He also completed a number of managerial courses in Poland and abroad: Project Portfolio Management – OMEC (2014), Conscious Leadership – MPS (2013), Leadership Training Corporate Management Platform – Ramirent PLC (2010), Young Business Talents – Smithfield (2000), and Cooperative Management – VOCA (1998).

Since 2017, he has been Vice President of FAMUR S.A.'s Longwall Systems Segment, responsible for sales, since January 2018 – Vice President of the FAMUR S.A. Management Board, and since January 1st 2019 – Vice President of the Management Board, Underground Segment Export Sales. He began his professional career at BRADO companies, where he served as President of the Management Board of Z.M. BRADO 2 S.A. He also held the position of President of the Management Board of RODO SRL of Romania and of Lodus Sp. z o.o. He was Head of the Distribution Centre at Animex S.A. (Smithfield Foods Incorporated), and in 2000–2015 he worked for the RAMIRENT Group of Finland, where he served as Director of the South Region, Vice President of the Management Board of RAMIRENT Scaffolding Sp. z o.o., and Member of the Management Board of RAMIRENT S.A.
