Further to Current Report No. 56/2015 of December 30th 2015 and Current Report No. 4/2016 of January 15th 2016, the Management Board of FAMUR S.A. of Katowice announces that today it was notified that on July 1st 2016 (the merger date) the District Court for Katowice-Wschód in Katowice, 8th Commercial Division of the National Court Register, registered the Company's merger with the Elgór+Zamet sp. z o.o.

The merger was effected under Art. 492.1.1 of the Commercial Companies Code, i.e. through transfer of all assets of the acquiree to the acquirer with a concurrent increase in the share capital of the acquirer (FAMUR S.A.). In connection with the merger, the Company's share capital will be increased by PLN 49,700.00 (forty-nine thousand, seven hundred złoty), from PLN 4,815,000.00 (four million, eight hundred and fifteen thousand złoty) to PLN 4,864,700.00 (four million, eight hundred and sixty-four thousand, seven hundred złoty) by way of issue of 4,970,000 (four million, nine hundred and seventy thousand) Series C ordinary bearer shares with a par value of PLN 0.01 (1/100 złoty) per share and a total par value of PLN 49,700.00 (forty-nine thousand, seven hundred złoty) (the "Merger Shares").
