**Notification made by TDJ Equity I sp. z o.o. company under Art. 69 of the Public Offering Act**

Legal basis:

Art. 70.1 of the Public Offering Act – acquisition and disposal of major holdings of shares

Text of the report:

The Management Board of GRENEVIA S.A. of Katowice (the “Issuer” “Company”) announces that today it received a notification from its Shareholder - TDJ Equity I sp. z o.o. of Katowice (the “Notifying Party”), dated 7 March 2025, in which the Notifying Party, acting pursuant to Art. 69.1.1) in conjunction with Art. 69.1.1), Art. 69.2.2) and Art. 87.5.1) and Art. 77h.3 of the Act on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies (consolidated text: Dz.U. of 2024, item 620) (the “Act”), notified the Management Board of GRENEVIA S.A. that TDJ Equity I sp. z o.o. of Katowice acquired 150,854,527 (one hundred and fifty million, eight hundred and fifty-four thousand, five hundred and twenty-seven) ordinary bearer shares in the Company, as part of a tender offer for the sale of shares of Grenevia S.A. of Katowice, announced on 15 January 2025 by TDJ Equity I Sp. z o.o., pursuant to Article 72a.1 of the Act. The Notifying Party increased his holding of total voting rights at the Issuer’s General Meeting by more than 1%, thus as a result of the tender offer it currently has 76.84 % of total voting rights at the Company’s General Meeting, exceeding the threshold of 75% of the total voting rights in the Company.
